3. Chair's report

Good afternoon. Firstly apologies we are not able to join together in person as planned but great to see you all online. I'll start with my usual thank-you across the whole of our committee, with particular thanks to Phil as Secretary and Vivian as Treasurer.

Throughout 2023 we have kept a steady momentum of engagement and connection with our committee with a series of in-person events and a big focus around networking and theme of sustainability running through our events. We held a couple of our events in Burlington House, as well as travelling once again to be with our national formulation centre friends at CPI. As usual our MIBio event was held in Cambridge – this is the 11th year for this hugely successful conference series and we are pleased we were able to offer the opportunity to one of our new committee members to help with the organisation of this established event. We saw the return of the Formula series with this large international conference held in Lille, with a hybrid link available to those who were not able to attend in-person. We were very pleased one of our committee members was able to attend, not only for the conference, but also to represent the FSTG in the International Advisory Board meeting on formulation that took place after the event. We are excited to continue our active involvement in both the IAB and the EUChemS Working Party in Formulation in Chemistry which connects the formulation community across the world. We were also present at the launch of the RSC's Sustainable Polymers in Liquid Formulation (PLFs) Mission, as well as joining the Member Network Conference and Interest Group Forum. A huge thank you to all those who organised, ran, promoted and attended our activities. Building a culture which is inclusive and welcoming to all, within our committee, across of events is something we continually work on and challenge ourselves on. We are looking forward to a jam-packed 2024 which will be kicked-off with our postponed Innovations in the formulation of Amorphous Solid Dispersions event. As a committee we will come together on an Away Day to spend time planning the next 3-5 years of activities. This is really important time for us to consider how to best shape our interactions and connection with the broad formulation community. You'll hear shortly that our interest group remains very much in the black in terms of finances (~£100k) and are always keen to hear how we can spend some of our funds for effective support of the formulation community. Our drive and purpose remains very



much in line with the RSC to advance the chemical sciences and is about bringing the formulation community together. On a personal note I just want to end with yet another thank you to all those who have engaged with us over this past year – if you have suggestions on events you'd like to see please do get in touch, and finally thanks to all my fellow volunteers. It's sad to say goodbye to Simon – previous Chair and Secretary and real catalyst for our 2021 Inspirational Committee Award – who completes the end of his term, as well farewell to Chris who joined as an early career researcher in 2018 and spearheaded our Formative Formulation series. We are so pleased that this will continue with one of our new early-career committee members. Looking forward to continued engagement with all our past members, and continuing to find new members, through our activities. I wish you a very Merry Christmas and a Happy New Year.



4. Treasurers report (Dec 2023 End)

As we wrap up another successful year of organising scientific conferences, we are pleased to present the treasurer's report.

As of the end of 2023, our funds amount to £28,152.29 in our NatWest current account. Additionally, we hold £81,055.40 in a 'high' interest account, resulting in a total of £109,207.69. This reflects a positive increase from the £108,227.45 we had at the end of 2022.

Our income for the year stood at £14,421.91, a testament to the continued support from our FST community, sponsors from Industry and the RSC.

Our expenditures amounted to £16,846.82 reflecting a small loss for the necessary costs associated with organising our events as well as supporting travel costs for committee members and conference speakers.

Two members have left the committee this year:


- (1) Chris Ness joined the committee in Dec 2021 and has been involved in the organisation of many meetings including the Formative Formulation meeting series.

FSTG Membership in 2023 has remained steady at 1343, membership in recent years has been:



- **11. Maria Inam** new member elected in Jan 2023, following response to open call, to serve 4 years. Committee membership to be reviewed in **Jan 2027**. *Not previously committee member*.
- **12. Bindhu Gururajan** new member elected in Jan 2023, following response to open call, to serve 4 years. Committee membership to be reviewed in **Jan 2027**. *Not previously committee member*.

Co-opted members:

- Ian Howell elected as co-opted member in September 2018. Not an RSC member.
- **Kevan Hatchman** completed 2 terms of 4 years by Dec 2020. Co-opted in Dec 2020. Committee member since 2012.

Non-voting members:

• **John Jones** – elected in AGM Dec 2017 to continue to serve as a non-voting member. Previously served as committee member from 2008-2017.

Following the AGM there will be 12 members (+ 2 co-opted and 1 non-voting members) on the committee. During 2023 Chris Ness and Simon Gibbon stepped down from their role as an ordinary member on the committee.
